1. Introduction

Dear member,

The Trade on Behalf (ToB) process aims to be a supporting tool when isolated issues occur disrupting your connection with the ETS system. In this case, you can download the excel forms from our website for the respective auction from this <u>link</u>.

The ToB process is meant to be operated on a best effort basis, this is why we advise you to call our Market Operations department as of when you have emailed the forms and also to try to send the form(s) as soon as possible in order to ensure they will be processed correctly (avoid waiting until close to the OBK time).

2. Business process

Below you will find the instructions on how to fill in the form and how to send it to Marker Operations Team for validation.

The form has to be sent 15 min before the gate closure time at the latest. The form needs to be sent by e-mail.

2.1 Download the excel forms from our website

Select the correct form based on the type of order (linear / block) and 25Hours for Long Day DST or the ones for normal day.

- The ones for the normal day should be used for Short Day DST without filing in the impacted periods.
- 2.2 Filling of the excel form

Fill in the trader name (**only authorized traders** are allowed to send a ToB form and request its submission) and the respective portfolio as well as the type of the order (new, modification of existing one or cancellation of an existing one).


