Chapter 1 Disclaimer

MEPX Trader Client offers a great deal of flexibility to exchanges to configure new products. Considering the generic nature of the MEPX Trader Client, and thus this manual, some products and functionality described in this document may not be available to you.

This guide is intended for Traders.

Assumption throughout this guide is made that the reader has full authority and permission to perform the actions required.

Consult the MEPX Client Guide for further details about functionality once the installation has completed.

Chapter 2 ETS Client Installation

This guide is intended for MEPX Traders.

Please refer to your market rules regarding availability of described functions.

Assumption throughout this guide is made that the reader has full authority and permission to perform the actions required.

There are two different MEPX Clients available.

The MEPX Fixed Version Client is the full client, containing all program logic needed to perform trader actions. The MEPX Fixed Version Client however is not able to update to the latest program logic, making a new manual installation necessary when such code becomes available.

Default installation directory: C:\Program Files (x86)\ETS Client for MEPX (version)

The MEPX Upgradable Client is the full client, containing all program logic needed to perform trader actions. The MEPX Upgradable Client is able to update to the latest program logic, and will automatically update itself to the latest version when such code becomes available. This ensures the client software is always up to par without the need to manually collect and install a newer version.

IMPORTANT:

Due to evolving security measures, options for upgrading with earlier versions of the the Upgradable Client are limited. Please consult the Helpdesk in case of questions or issues.

The executable (.exe) collected from the exchange via the Upgradable mechanism, will be saved by default in:

C:\ProgramData\EPEXTradingSystem\MEPX\<version>

Both the MEPX Fixed Version Client and the MEPX Upgradable Client will perform identically once the login procedure is completed, given the version of both the clients is the same.

ClientSettings.xml is a local file that contains the basic connection settings needed to connect to the exchange. Each version of MEPX Client has its own file. The settings file for Windows is situated in:

C:\Users\<User>\AppData\Roaming\EPEXTradingSystem\MEPX\<version>

The **MEPX Trader Client** consists of all functionality needed to perform trading related actions on the MEPX Trading Systems installed on your local machine. In order to get up-to-date functionality, manual installation of the latest version is required.

Please note that it is not possible to install both Fixed and Upgradable versions at the same time on the same machine.

2.1 Requirements

Recommended system requirements for the client computer:

Multi-Core processor, 4GB internal memory, 100 MB of free Hard Disk space. Each upgradable client version collected from the exchange server is locally stored, requiring approximately an additional 15Mb per version.

Minimum Supported operating systems:

Windows10 Pro or Enterprise, or newer, Server 2016 or newer, MS Excel, 2016, 2019, locally installed, Please note that MS Excel Viewer is not supported.

The above is valid according to the Microsoft Lifecycle Policy for these versions.

Network settings:

MEPX Trader Client requires a stable Internet connection. Recommended minimum connection speed is 256Kbit/s or better. All traffic is TLS encrypted.

Proxy support

The MEPX Trader Client does support connecting to an exchange using HTTP CONNECT proxy servers.

Please see the HTTP Proxy Settings chapter in the Trader Client Guide for more details.

Note:

Using an Upgradable client on Citrix is not recommended.


2.2 The Install Process

Double-click the installation file as received from the exchange.

ETS Client for MEPX (version).msi

The installer wizard will now guide you through the installation steps.

In all screens, press **Cancel** to terminate the installation process. Press **Back** to revert to the previous step in the installation process.



Press Next.

The installer wizard now asks for the installation directory.
